

PPSL **End Year Meeting**, (Revision 6/6/12)

St Catherine's School

May 29, 2012

Ellie Rapp called the meeting to order at 7:10 pm
Roll call was taken...all schools present except Notre Dame

Cheryl, League Scheduler, collected the Baseball and Volleyball Commit forms from school Commissioners.

Ellie passed around the PPSL AD roster and Baseball/Volleyball Commissioner rosters, asking commissioners to check each roster and make any necessary corrections.

Ellie asked for volunteers to host the 6th grade basketball division playoffs, March 1, 2, 3. OLA volunteered from the North, St Charles and St Pius from the South, St Charles will host the games on March 1st & 2nd, and St Pius will host the div championships on Sun. March 3rd.

A motion to approve the Nov. 11th Basketball minutes was made by Bill from Nativity and seconded by Kevin from OLA. Motion passed, minutes were approved.

Tony, Athletic Director from St Matt's:

Spoke about upcoming free coaches 'clinics for volleyball on July 24, July 26, July 31 and August 2 from 8:30 to 10 pm at Paye's Place. Check Paye's Place web site for additional info. He also spoke about other opportunities for kids at Paye's Place.

BASEBALL ONLY MEETING:

Will be held on Tuesday, June 5th at 7:00 pm at Our Lady of Mount Carmel in Redwood City

Ellie discussed the Archdiocese requirements for coaches. All coaches must complete the Shield the Vulnerable training and Live Scan fingerprint requirements. She recommended completing the Live Scan, rather than the background check. Background checks must be redone every 3 years, coaches who complete background in place of the live scan may only coach with a compliant head coach who completed the live scan requirement.

All Baseball and Volleyball player rosters are due to Ellie by August 31st. You may scan and send your rosters to Ellie, but the original must be sent to her. If a player or coach is not listed on the roster, he/she may not participate or coach in any game. (Ellie will send you copies of the 2012 Baseball & Volleyball rosters).

Voting on proposed rule changes:

General Rules:

Rule 3.11: change wording on trophies to Division 1 League Champs, etc. For 8th grade only, award a Championship Tee Shirt to the No/So winners.

Vote: 14 Yes – 1 No, Passed

Baseball Rules...were tabled, we will vote on the changes submitted at the Baseball meeting on Tues. June 5th at Mt Carmel 7:00pm.

Volleyball Rules:

Amend Rule 5.17: Every non-injured team member present at the match must play one uninterrupted game in total of that same match. Except in the case of injury or illness, teams may not substitute players once they have submitted their rotation for a game or any time during the course of the same game.

Vote: 10 No 5 Yes: Did not pass

Add to Rule 5.11: Include all regular season scores, game & match, in weekly standings report.

Vote 13 Yes, 2 No: Passed.

Add Rule 5.14: At the 3rd game, team switch sides at point 8 of the game.

Vote: 12 No, 3 yes: Did not pass.

Add to 4th grade training games: move the boundary line to half court for all training game.

Vote: 10 No, 5 yes: Did not pass

Change to Division 1, 2, 3 for 7th and 8th grade divisions, for the upcoming 2012 season.

Vote: 14 Yes, 1 No: Passed

Basketball Rules:

4th Training Changes: all defenders must play defense inside the 3 point ARC.

Vote: 13 Yes, 2 No: Passed

The Basketball Competition Rule 6.14 was tabled;

Mike Maher, League Represented offered to rewrite this rule (6.14) and present it to the basketball commissioners for a vote at the Basketball meeting to be held in November.

A recommendation to change our league divisions to “Small/Large school divisions” **was withdrawn.**

A presentation as to restructure our current ‘Playoff Rule 7.6’ was submitted for discussion, all members voted to adopt the current restructure of the playoff rules for the 2013 sport season.

Rule 7.6: Tie Breaking Formula...**All present agreed to adopt the new restructure for 2013.**

Requests: St Pius and St Catherine’s would like to submit a Sharks 7 volleyball team without a Junior Varsity volleyball team if the Division 1, 2, 3 format is not adopted for the 2012 season.

All the above changes, etc. submitted at tonight’s meeting were upheld by the members of the Executive Board.
